

CITY COUNCIL REORGANIZATION MEETING
MONDAY, JANUARY 4, 2016, 8:00 P.M.

CITY COUNCIL CONVENED IN A REORGANIZATION SESSION AND WAS CALLED TO ORDER BY PRESIDENT CHARLES P. SAMMARONE. 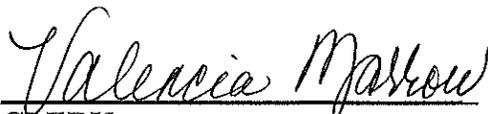
